Cogdell Cemetery Association

The Cogdell Cemetery, located approximately 9 miles west of Lexington, TN in the Second Civil District of Henderson County being more particularly described as a 1 acre tract on the north side of U.S. HWY 412 W and recorded in Henderson County Deed Book 219 pages 179-185, has a cemetery association for the operation and preservation of the Cogdell Cemetery.

Articles & Bylaws of Cogdell Cemetery Association Committee

1. This association shall have the responsibility to insure that the proper upkeep and maintenance of Cogdell Cemetery is always met.
2. Committee shall be composed of at least three members-present members are Wilma Sutton Cogdell, Magrette Cogdell Young, and Bobby Lee Cogdell.
3. Committee members must be a direct descendent of the Henderson County Cogdells or married to a direct descendent of a Henderson County Cogdell.
4. Committee members have control of the Cogdell Cemetery fund accounts.
5. Cemetery fund accounts can only be used for the upkeep and betterment of the cemetery.
6. The committee shall appoint a treasurer who shall have the authority to write checks up to \$300.00 for the maintenance of the cemetery. The treasurer shall maintain records of all expenditure for a period for five years. Withdrawal from the savings account can only be made with at least 2 of the 3 members' written consent.
7. Proper documents must be maintained to show how cemetery funds are used.
8. Committee members shall have final authorization on burial sites within cemetery.
9. In the event of a vacancy on the committee, then the remaining members shall fill the said vacancy with the appointment of someone who meets the qualifications of Article # 3.
10. Committee members have the duty to transact any business that's related to said cemetery.

11. Committee members reserve the right to make addition to these bylaws as the need may arise.
12. This document shall be recorded in the Registration of Deeds Office in Henderson County, TN.
13. The Cogdell Cemetery Association is a non-profit organization, whose sole purpose is the upkeep and preservation of Cogdell Cemetery.
14. No compensation shall be paid to any committee officer for their duties on behalf of the said Cogdell Cemetery Association.
15. No certificate of deposit of the Cogdell Cemetery Association can be used as collateral for a loan or can be borrowed against.
